RMHC IN OMAHA PROVIDES A SUPPORTIVE HOME-AWAY-FROM-HOME FOR FAMILIES WHO BRING THEIR CHILDREN TO THE OMAHA COMMUNITY FOR MEDICAL CARE. IN 2017, WE PROVIDED 126 UNIQUE FAMILIES WHOSE CHILDREN RECEIVED TREATMENT AT MEDICAL CARE FACILITIES IN AND AROUND THE OMAHA, NEBRASKA AREA WITH HOUSING. THE AVERAGE LENGTH OF STAY BY FAMILIES IN 2017 WAS 23 DAYS. TO BE ELIGIBLE TO STAY AT RMHC IN OMAHA, FAMILIES MUST HAVE A CHILD 21 YEARS OF AGE OR YOUNGER RECEIVING MEDICAL CARE AT AN OMAHA AREA FACILITY AND LIVE MORE THAT 35 MILES AWAY FROM THE HOUSE. RMHC IN OMAHA DOES NOT REQUEST OR REQUIRE PAYMENTS FROM FAMILIES WHO STAY AT THE HOUSE.

THE RONALD MCDONALD CARE MOBILE IS A PARTNERSHIP WITH ONEWORLD COMMUNITY HEALTH CENTERS FOR DELIVERING DENTAL CARE AT NO COST TO CHILDREN AND THEIR FAMILIES. TOOTH DECAY IS THE MOST COMMON CHRONIC CHILDHOOD DISEASE AND AN ESTIMATED 20% OF ALL LOW-INCOME CHILDREN HAVE NEVER VISITED A DENTIST BEFORE ENTERING KINDERGARTEN. THE CARE MOBILE PROVIDES DENTAL CLEANINGS, SEALANTS, AND ORAL HEALTH EDUCATION TO CHILDREN WHO OTHERWISE MAY GO WITHOUT. IN 2017, THE CARE MOBILE CARED FOR 1009 CHILDREN, VIA 1,846 VISITS AND AT 35 SITES ON THE CARE MOBILE.
